BALLYMONEY OLD VEHICLE CLUB

- 1. The Club shall be named Ballymoney Old Vehicle Club.
- 2. The Club shall meet at 8pm on the last Monday of each month at the premises of Ballymoney Football Club.
- 3. The Club shall hold an Annual General Meeting in October of each year.
- 4. The officers and resident committee of the club shall be elected by majority vote at each year's AGM.
- 5. The officers shall be President, Vice President, Chairman, Vice Chairman, Treasurer/Assistant and Secretary/Assistant.
- 6. A committee of not less than six persons shall be elected by majority vote at each year's AGM.
- 7. Membership fee shall be set by resident committee before each year's AGM.
- 8. Selection of members shall be the responsibility of the resident committee.
- 9. A person shall be deemed a club member, after application and acceptance, and having paid the appropriate fee to the Club Treasurer.
- 10. The Treasurer shall be responsible for all the financial matters within the Club.
- 11. A member shall have their membership rescinded if that member has, by discretion of the resident committee brought the Club or its members into disrepute by ay words, actions or behaviour which tends to damage the good name of the Club, its members or its functions.
- 12. All complaints must be in writing and handed to a committee member or office bearer. The resident committee will consider all complaints in the strictest confidence and rule on the same by majority vote. The outcome of which will be Final and Binding.
- 13. The Resident Committee will inform any member dismissed from the Club that their subscription will be forfeited to the Club after consideration by the Committee.
- 14. All applications for membership must be made in person by the applicant attending at least one meeting of the Club.
- 15. New members must be proposed by a current Committee member of the Club.
- 16. The Club will not be responsible for any loss, damage to any property whatsoever, belonging to any member or for any injury caused to any member whilst acting for or under direction of the Club, its Officers or Committee.
- 17. No Club member or contemporaries of the Club shall present any vehicle relative to the Club events, functions or outings without relative insurance for that vehicle which complies with Road Traffic Regulations and amendments thereto.
- 18. This list of the Club rules may be amended as seen fit by the Resident Committee on a majority vote.
- 19. Club membership is due in October each year. Anyone who has not renewed their membership by December will have to complete a new proposal form to rejoin the Club.
- 20. A new member must complete two years full membership before being eligible for an official position within the Club.
- 21. The Resident Committee will set concessions on all Club events.
 - 21a. Members must have at least six months membership before concessions apply.
 - 21b. Members must attend at least 50% of Club activities, attendances will be reviewed by Committee.
